PURPOSE OR NATURE OF PROJECT: The project will replace a substandard bridge crossing the Middle Fork Beaver Creek located 15.5 miles west of

NOTICE OF FINDING OF NO SIGNIFICANT EFFECT ON THE ENVIRONMENT

It has been determined that such request for release of funds will not constitute an action significantly affecting the quality of the human environment and, accordingly, the above-named County has decided not to prepare an Environmental Impact Statement under the National Environmental Policy Act of 1969 (P.L. 91-190).

The reasons for such decision not to prepare such Statement are as follows:

The implementation of this project will not adversely affect the environment.

An Environmental Review Record respecting the within project has been made by the above-named County which documents the environmental review of the project and more fully sets forth the reasons why such Statement is not required. This Environmental Review Record is on file at the above address and is avail-

able for public examination and copying, upon request, at Sherman County, 813 Broadway, Goodland, KS 67735 between the hours of 8:00 to 12:00 a.m. and 1:00 to 5:00 p.m.

No further environmental review of such project is proposed to be conducted, prior to the request for release Of Federal funds.

All interested agencies groups and persons disagreeing with this decision are invited to submit written comments for consideration by the County to the office of the Chairman. Such written comments should be received at Sherman County, 813 Broadway, Goodland, KS 67735 on or before 15 days after date of this Notice. All such comments so received will be considered and the County will not request the release Federal funds or take any administrative action on the within project prior to the date specified in the preceding sentence.

NOTICE TO PUBLIC OF REQUEST FOR RELEASE OF FUNDS

Sherman County will undertake the project described above with Block Grant funds from the Kansas Department of Commerce & Housing (KDOC&H), under Title I of the Housing and Community Development Act of 1974. Sherman County is certifying to KDOC&H that the

County and Kevin Rasure in his official capacity as Chairman, consent to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to environmental reviews, decision making, and action; and that these responsibilities have been satisfied. The legal affect of the certification is that upon its approval, Sherman County may use the Block Grant Funds and KDOC&H will have satisfied its responsibilities under the National Environmental Policy Act of 1969. KDOC&H will accept an objection to its approval of the release of funds and acceptance of the certification only if it is on one of the following basis: (a) that the certification was not In fact executed by the chief executive officer or other officer of applicant approved by KDOC&H; or (b) that applicant's Environmental Review Record for the project indicates omission of a required decision, finding, or stop applicable to the project In the environmental review process. Objections must be prepared and submitted in accordance with the required procedure (24 CFR Part 58), and may be addressed to the Kansas Department of Commerce & Housing, Small Cities CDBG Program, 1000 SW Jackson Street, Suite 100, Topeka, Kansas 66612-1354. Objections to the release of Funds on

basis other than those stated above will not be considered by KDOC&H, Objections must be submitted within 15 days following receipt of the request for Release of Funds by KDOC&H.
