### ORDINANCE NUMBER 1616

AN ORDINANCE VACATING A PORTION OF RAILROAD RIGHT OF WAY LOCATED WITHIN LOT THREE (3), IN BLOCK TWO (2) OF THE GOODLAND INDUSTRIAL PARK, SITUATED IN THE SE/4 OF SECTION 24, TOWNSHIP 8 SOUTH, RANGE 40 WEST OF THE 6 P.M., IN THE CITY OF GOODLAND, SHERMAN COUNTY, KANSAS, AND UNDER THE AUTHORITY OF K.S.A. 14-423.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GOODLAND, SHERMAN COUNTY, KANSAS:

Section 1. For good cause shown and it being deemed expedient by the Governing Body of the City of Goodland, Sherman County, Kansas, the said Governing Body does hereby vacate the following platted and dedicated railroad right-of-way within the City of Goodland, to-wit:

Commencing at the Northwest corner of Lot Three (3), Block Two (2) of the Goodland Industrial Park, thence South approximately 320' to the South line of the Goodland Industrial Park as set forth in the plat dated June 7, 1982, and filed June 7, 1982, at 11:00 a.m., and recorded in plat folder 36, in the office of the Register of Deeds of Sherman County, Kansas; thence East 125.79', along the South line of the Industrial

Park, to a point; thence, on a curve with a radius of 287.94', for distance of 280.05', to a point; Thence, North 82.06' to the North line of Lot Three (3), Block Two (2), in the Goodland Industrial Park; thence West 20', more or less, to the point of beginning. This description is situated within the Goodland Industrial Park, which is in a portion of the Southeast Quarter (SE/4) of Section Twenty-four (24), Township Eight (8) South, Range Forty (40) West of the 6th P.M., in Sherman County, Kansas

Section 2. This ordinance shall become effective thirty (30) days after the date of publication thereof, unless one or more interested parties file a written protest before the expiration of such time. In the event such protest is filed in the office of the City Clerk of the City of Goodland, Kansas, within said time, the Governing Body shall set the same for hearing ten (10) days after the end of the thirty (30) days above mentioned. At the conclusion of said hearing, the Governing Body shall adopt a resolution confirming the vacation ordinance or in the event such resolution is not adopted, the vacation ordinance shall be void and of no effect. Upon this ordinance becoming effective, either without objection or by resolution as above provided for after objection, the City Clerk will take a certified copy thereof to the office of the Register of Deeds and the County Clerk of Sherman County, Kansas, as

provided by K.S.A. 14-423.
