## Attempted murder charges filed


A man and woman who were arrested after a chase on Interstate 70 last month where the passenger shot at pursuing Kansas Highway Patrol troopers have been charged with two counts of attempted first degree murder by the Kansas attorney general's office.

The chase started Sunday, Jan. 16, about eight miles east of the Colorado line and ended on a county road about two miles north of Brewster when a trooper returned fire and hit the man driving the fleeing vehicle.

Anthony Douglas Patrick, 30, driving a blue Toyota Scion, was stopped about 7:20 p.m. because the car did not have any license plates. His passenger was Piper Lacey Stout-Briese, 30, and the Toyota

belonged to her grandfather from Colorado.

Trooper Perry Frey reported he stopped the vehicle. When he asked for the registration, the man took off. Frey followed with his lights on, and the Toyota stopped again about a mile later. As Frey started toward the vehicle, the driver took off.

The trooper told the dispatcher he was in pursuit and asked for help from Sherman County deputies to

set up "stop sticks" to deflate the car's tires at the west Goodland exit.

Frey reported following the Toyota at speeds of up to 90 mph as they approached the exit. He said a man was driving with a woman passenger that he could see.

Sherman County Deputy Asa Stiles had stop sticks ready, but the driver swerved to avoid them and the chase continued east with the trooper and two Sherman County officer behind.

Trooper Charlie Brattin had stop sticks set up at the Edson exit and Trooper Terry Kummer was waiting with another set at the Brewster exit.

As the Toyota went past the Goodland exit, a sheriff's deputy said he saw something sticking out of the window on the passenger side.

As the car sped east, officers said, the passenger began firing at Frey's car. He reported his car had been hit, but he continued following the Toyota. Frey's car took a bullet in the windshield.

As the chase approached the Edson exit, Frey warned Brattin to take cover. The Toyota hit the stop sticks but continued east at a slower speed. Brattin's car was hit by a bullet near the gas filler cap.

The chase continued to the Brewster exit, where the Toyota turned off and went north toward Brewster with the trooper closely behind.

Permission was given for the troopers to use "intervention tactics" with their cars to stop the car after it had hit the stop sticks at Edson, and finally permission was given for the trooper to use "deadly fire." Trooper

Frey was able to shoot the driver in the shoulder, and he stopped about two miles north of Brewster on Thomas County Road 2.

By that time, a Thomas County deputy and two Colby police officers has joined the patrolmen and Sherman County deputies in the chase. Ambulances from Goodland and Colby were called.

Patrick and Stout-Briese were arrested and taken to Goodland, Patrick in an ambulance. The driver was flown to a Denver hospital to have the trooper's bullet removed from his back left shoulder and then returned to the Sherman County Bastille.

The Kansas Bureau of Investigation was called in because the officers had been involved in the chase

## Commissioners ponder employee insurance changes

Employee health insurance was the agenda topic on Friday for two Sherman County commissioners looking for information on what the future holds and options the commissioners may face as they balance cost against protecting a valuable employee benefit and the commissioners were expected to approve renewal of the existing insurance plan at today's meeting.

Commissioners Larry Enfield and Cynthia Strnad met Friday morning to go over the insurance options with Rhonda Fernandez of Professional Insurance Consultants of Dodge City, who was hired last year to review the county benefits and recommend possible changes.

The special meeting was held because Enfield was not available for the commission meeting on Monday when Charles Krull, area representative of Blue Cross and Blue Shield, presented figures for a possible partial self-funded program for Sherman County.

Strnad said she wanted the county employees to understand it is not the intent of the commissioners to dump a new plan on them.

"We want to protect our employees," she said. "We do not pay high wages, and the health insurance is an important part of their benefits."

Fernandez said she agreed any changes are not designed to hurt the employees, but it is taxpayer money and it is important for the commissioners to look at the options.

"I know it can be a small step process to make the changes that might help in the future," she said.

Krull had presented the insurance renewal figures in January

showing a 6.6 percent increase, and mentioned the possibility of a partial self-funded option the county might consider. Monday Krull had presented the self-funded option to Commissioner Max Linin and Strnad.

Friday Fernandez reviewed the various options including the Blue Cross and Blue Shield self-funded option.

She said one of the problems her consulting company is having is not getting the renewal information from Blue Cross and Blue Shield early enough to make good comparisons.

She recommended the county have County Clerk Janet Rumpel write a letter to Blue Cross asking for the renewal information to be delivered by December 15 to give her time to do a good review and develop other options.

She said Rumpel had written and asked Blue Cross and Blue Shield for a utilization report the county had not been getting. She said the report lets her company know what the employees are actually using. She said the county should get two reports a year, but has to ask for them. She said the reports do not give names, but do provide a lot of good information.

Fernandez said she felt the Blue Cross and Blue Shield renewal figures were not bad, but wants the county to look at other options as well to see what might be available.

The Blue Cross and Blue Shield self-funded option appeared to be a small savings \$829,968 over the fully funded costs (\$836,841).

The class will discuss thunderstorm formation, organization and evolution, associated clouds

and their meaning, thunderstorm hazards, safety, and what and how to report.
