## Three Cowboys place at 3-2-1A State Wrestling

Goodland Cowboys took five wrestlers to the 3-2-1A State Wrestling Tournament in Hays and came back with three medals and a 10th place finish in the

Cowboy senior Seth Miller finished second at 130 pounds; senior Nathan Deeds finished fifth at 145 pounds and junior Laine Herl finished fourth at 189 pounds.

The Cowboys finished tied for 10th with Phillipsburg with 51.5 points. Norton won the tournament with 131.5 points, Hoxie second, 97, Rossville third, 84, Scott City fourth, 81.5, Eureka fifth, 70, Smith Center sixth, 69.5, Beloit seventh, 57, Burden-Central eighth 54.5, and Oberlin ninth, 52.

Cowboy Coach Joe Sramek said he was proud of the Cowboys efforts, and felt they had a good opportunity in the tournament. He said a couple of the matches were close and could have gone either way.

None of the Cowboys were eliminated quickly, and had a chance to work their way into the medals.

Two Cowboys did not place junior Austin Avelar at 119 pounds and junior Riley Oharah at 215 pounds.

Avelar, Miller, Deeds and Herl all won their first round matches, but Oharah lost to drop him into the consolation bracket. **Individual results**




