In compliance with the provisions of K.S.A. 25-2310 and K.S.A. 25-2311, notice is hereby given that the books for registration of voters will be open at the following places at the times specified:

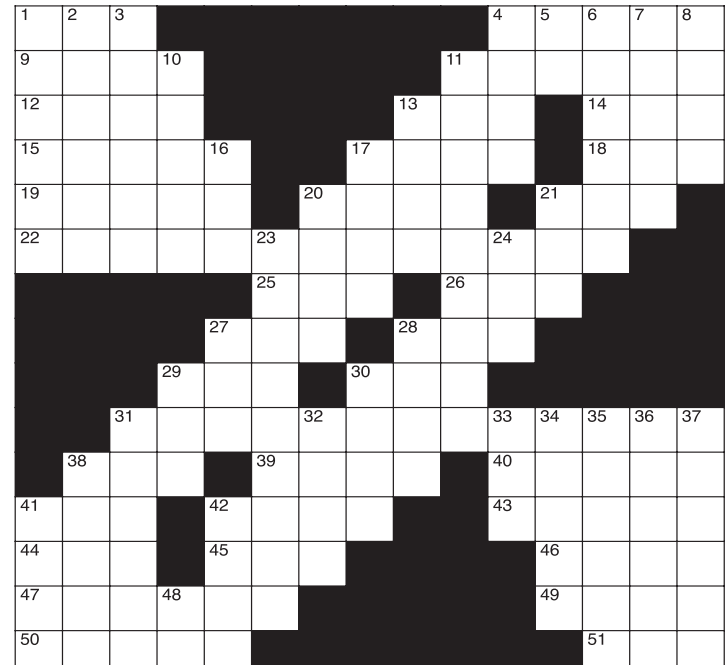
