City approves playground deal

Steever Park may get an upgrade this summer with approval by the city commission to approve a deal from GameTime for new playground equipment.

City Manager Doug Gerber said the quote from GameTime of Charlotte, N.C., is for two sets of playground equipment. He said the staff–especially Amy Thorson–

has been working with GameTime, and they offered a 50 percent discount on the equip-He said the total cost for the equipment was

\$64,624, with one set being for younger children, and the other for older children. He said the company is offering a discount of \$31,240 to bring the cost down to \$37,815.

"It has been a while since playground equip-

ment has been purchased," Gerber said. He said money has been put away for park

improvements and \$94,000 is available.

"This is probably a good approach for whatever park we use," he said. "We are recommending Steever Park, or any park in the city. Most of them are in dire need of playground equipment. The parks are well used and we have gotten our money's worth out of the existing equipment."

Commissioner Annette Fairbanks said when the city put in the new water park it was clear something needed to be done with the playground equipment at Steever Park. She said she was in favor of going ahead with it.

Commissioner John Garcia said he had seen increased use of Steever Park and a lot of people are using the shelter and skate park.

Dechant asked about graffiti, and Gerber said he felt the equipment is probably resistant and washable.

Garcia said he felt it was great with the savings that Amy got, and made the motion to approve the purchase less the supervision cost. Fairbanks seconded and it passed 5-0.

The blank slate approach was the consensus of the city commissioners, county commissioners and rural fire board at a special meeting held Tuesday evening at the city administration building.

The special meeting was held to discuss the recommendations made by Harold N. "Skip" Starling, president of National Fire Services Office of Savanna, Ga., who had been hired to do a survey of fire services in Sherman County. His recommendations were presented to the same group at a special meeting held at 9 a.m. on Tuesday, March 22.

At the joint city, county and fire board meeting on Tuesday the discussion was about implementing recommendations made by Skip Starling of National Fire Services Office of Savanna, Ga., who had presented his recommendations to a similar meeting the week before.

Darrel Cloyd of the Sherman County Rural Fire Board said they had met on Monday and discussed the pros and cons of the recommendations and possible consolidation.

City Manager Doug Gerber asked Cloyd what the fire board saw as the pros and cons of consolida-

Cloyd said the board talked about 11 things. The board felt consolidation would benefit the city by having more manpower to fight fires because together would have more than 30 firefighters.

Garcia was absent. County Commissioner Cynthia Strnad called the county meeting part of the discussion. to order and said she did not need to do a roll call as both Commissioner Larry Enfield and Commissioner

Dechant said the purpose of the meeting was to look at a game plan based on the recommendations Starling had presented the week

"We spent taxpayers dollars to do the study," he said, "and we need to make something happen. Anything we do will not happen overnight or be an easy process.

"We are dealing with the taxpayers money. Maybe we are duplicating the dollars and we need to keep the emotions to a minimum and look at the big picture. That is why we were elected."

Darrel Cloyd, chairman of the rural fire board, said the board held a meeting on Monday and went over Starling's recommendations and had a lot of discussion.

He said the board talked about the Brewster situation: where Sherman County appears to be paying the lions share, and agreed the agreement needs to be renegotiated. Cloyd said he had done some research on that and did not find a lot of answers, but that the negotiations appear to be with a township board.

He said they talked about upgrading equipment in Kanorado, and looked at the pros and cons of consolidation.

'We as a board decided we want to pursue a consolidation study," Cloyd said, "to see if it is the best thing for the people. That is what we want to do.'

Dechant asked Cloyd what the next step forward was. He asked if going with the satellite stations was
