like to have a 5, 10 and 20 year plan to set some long term goals and feel the goals need to be set together with the city and county commissioners.

Dechant asked if the fire board made the decisions or if they have to be approved by the commissioners.

Cloyd said the fire board serves at the pleasure of the commissioners. Strnad said the commissioners are supportive of the fire board.

Zimmerman asked if the planning was something the groups could do internally or have an outside person come in to help.

"Are we equipped to do it in house?" Cloyd asked.

Gerber said from the city perspective he expected the commissioners would suggest that staff look at what can be done and with Brian he would see what the city could be capable of doing. He said he did not see the city taking on the whole county study.

Cloyd said he felt it would be good to look at it as a blank slate and see what we need, and then look at what we have and what needs to be changed. He said it was looking at it out of the box.

Fairbanks said she liked the blank slate idea of looking at what is good for the county as a whole.

"Who know where the best place to start is," she said. "I feel we need to have assignments and deadlines and get moving forward."

Cloyd said an option was to hire a professional consultant.

Enfield said he felt the city and county had to get some numbers together and then they can sit down

Have better trained firemen with both getting the same training.

Save taxpayers money, and save on insurance premiums by lowering the ISO ratings. Have more equipment available for larger

fires. Gain more points for the ISO ratings. He said the fire board was learning a lot about the ISO

rating system. On the county side he said the benefit would be lowering the ISO ratings around each station if they can put in the satellite stations.

Again not have mutual aid situations.

Save money on duplication of equipment.

Have more manpower. Have better trained firemen.

Centralized purchasing.

Guidelines for countywide training.

Possibility of another full time person if there are savings.

Centralized leadership philosophy to get everyone on the same page, and countywide research.

City Commissioner Dave Daniels asked what Cloyd meant by research.

Fire board member Kevin Zimmerman said it would mostly be in the grants area and as a combined service might qualify for better grants.

Aquestion was asked if the ISO rating would go down if the city and county combined forces.

Cloyd said the county would gain points. "If we consolidate it does not save points unless you move one of the county stations," Daniels said.

Aquestion was asked about what the current might be best to put the stations. ISO ratings are for the city and county. City Fire Chief Brian James said the city is at 5 and Chris Bauman, assistant rural fire chief, said some of the county is at 9 and some are at 10. He said Brewster is at 8.

Dechant said with the changes there would be a way to reduce the 10s and have more 9s and possibly 8s.

A question was how much the lower of the ISO rating helped the insurance rates, but Gerber said Starling was not able to say specifically.

Cloyd said he felt if they went with the five mile radius around Goodland it would include the outlying communities of Paxton and Armstrong Additions and improve their ratings.

Daniels asked how Kanorado would fit in and Cloyd said the city would have their own department, but need a Class A pumper to drop the ISO rating.

County Commissioner Larry Enfield asked if the rural fire board was talking about moving the rural station out of Goodland. He said he did like Starling's presentation, but felt it basically went up and down I-70.

Cloyd said it was his feeling there would still be a rural station in Goodland. He said he had taken the idea of the 10-mile radius and used County Road 59 to Road 69 across the county. He said the county could gain quite a bit in lowering the ISO ratings if the put in the satellite stations.

Daniels said Starling had indicated he found the greatest impact based on where the highest number of houses are in that 10 mile radius. He not the city," she said. "We need to look a the agreed that might be a way to look at where it whole picture."

County Commissioner Cynthia Strnad said the ISO is important, but the rural firefighters respond to brush fires. She said looking at Brewster, "We cannot abandon the east third of the county," she said, "there may not be many houses over there, but when we renegotiate we need to make sure they do not feel abandoned."

Mayor Josh Dechant said he agreed and felt there has to be both a Class A and a brush truck to help in the satellite stations.

"My thoughts are not into building another station," Strnad said. "I think we have to have the leadership philosophy of one and train together and purchase together and use each others equipment.

"I think if we are looking at combining and making it more efficient we need to look at a Sherman County Community Fire Department rather than just the city or county fire."

City Commissioner Kevin Rasure said he felt the city and county need to have a plan and a goal. He suggested each side come up with some figures about what they have and what might be possible.

Dechant said he agreed they need to look at total dollars and feasibility of locating stations. He said the might not be looking at it being within five years, but between the city and county budgets they need to be talking about unification.

Strnad said she was not saying to look at consolidation, but to look at one picture.

Cloyd said he could ask. He said he would make some contacts and get back with the city and county.

Daniels said the city would meet on Monday, and asked if Cloyd could let the commission know what he has found out at least to see who might be available.

Cloyd said he thought he could do that.

Strnad said the commissioners could some listen at the city meeting, but would not meet until the second Tuesday of April.

Dechant asked if that was OK with everyone and got a nod of consensus.
