Goodland grad releases CD

"Stewards of Hope," a hymn of prayer and worship written and sung by Father Nick Parker, will be released Saturday - the anniversary of the death of Pope John Paul II. Father Parker was 2000 graduate of Goodland High School.

Father Parker said he was approached by Father Randall Weber to write a song based on the pastoral plan of the same title.

"It was the hardest song I ever wrote," Father Parker admitted. "Most of the songs I have written are more light-hearted and were done more for personal enjoyment."

Father Parker also said that the melody was dancing in his head as he wrote the words to "Stewards of Hope."

Donetta Robben, executive di-

rector of Divine Mercy Radio, said she first heard the song at Bishop Coakley's farewell Mass.

"It's a most beautiful hymn with a catchy tune," Robben said, who was part of the Stewards of Hope committee to put the pastoral plan together. "The words say exactly what Bishop Coakley was trying to accomplish with the Stewards of Hope pastoral plan, and I truly believe it is what God desires for his Church."

"As soon as I heard it, I just felt in my heart it needed to be recorded for all to hear."

In working with Father Parker, Father Weber and the board of directors of Divine Mercy Radio, Robben accomplished the goal of getting the hymn recorded. It was mutually

decided that Divine Mercy Radio would pay for the production, and share the profits with the Diocese of Salina.

Stewards of Hope was produced by Anthony Pfeifer, owner of The Tone Group.

"Father Nick always came to the studio well prepared and was very professional," Pfeifer said. It only took two tracks to cut the vocals. He's an excellent pianist and is just a nice person to be around."

Father Parker said he was humbled and honored to be asked to write the Stewards of Hope hymn.

"My hope is that Stewards of Hope will be used as a prayerful hymn to God to help us in our way of serving Him, and rally the faithful to be excited about serving

our Lord," Father Parker said.

Father Parker grew up in a musical home, as his mother is a piano teacher, and his sister is currently majoring in music-theatre in college. Ordained to the priesthood in 2008, Father Parker is the pastor of Sacred Heart Parish in Atwood, Assumption of Mary Parish in Herndon, and St. John Nepomucene Parish in Beardsley.
