Gerber was saying. Gerber said Fugleberg came in last year after the city started with a person who fell behind and was not getting a good job done.

Fire Chief and building inspector Brian James said people who bid do not think about what kind of job the mowing is. He said the process last year was the mowing contractor got a list of 25 lawns, and if they did not get then all done they got another list and fell behind.

He said Fugleberg had to use a tractor to go in and cut down some of the weeds that were as high as

three feet.

Rasure said it is hard, but if the contractor has better equipment and he gets it done quicker it may be better to pay the higher rate.

Mayor Josh Dechant said he was not sure the city has had a repeat person and that may be true because of the job it turns out to be.

James said he had 100 yards on the list he had to check every two weeks.

Gerber said the cost was \$11,891 for 397 hours. He said \$7,944 or about 67 percent was sent to Sherman County to be put on the tax rolls as liens against the property.

Gerber said it is and thinks it is about 5 mills at \$25,000 per mill for the city budget.

Cloyd said the rural fire district is capped at 5 mills, and are currently about 4.3 mills. The mill in the county raises about \$63,000.

Gerber said the fire chief has some preliminary research, but was not ready to talk about it in detail at this point.

The next step will be getting the proposals from the consultants to see whether an agreement at a reasonable cost is possible. Both the rural fire board, county commissioners and city commissioners had agreed to see if an outside consultant could be found to help lead the discussion on what could be the best model for fire service in the county including the city.
