Come out to the lake Saturday to watch some great Dutch oven cooking. The cooking will start at 8:30 a.m., judging will start at 12:30 p.m., and the awards and tasting will begin around 5 p.m.

A Dutch oven is a cast iron pot and is one of the oldest ways of cooking dating back to the early 1700's. Self service permits are available at all entrances and the ranger on duty can be contacted for annual passes and boating/OHV registrations. Passports can be stamped by accessing a box underneath the satellite dish west of the visitor center.

WATER LEVEL AND BOAT Join us for a day of fun at the park, RAMP; Lake elevation is 3655 or 14,500 ac/ft and slowly rising. About a foot and a half higher than last year at this time. We are anticipating levels to stay up until Labor Day. At the boat ramp the current depth is 4 to 5 feet and all boats are able to launch.

FISHING; Fishing for all species is good. Water temp is around 68 degrees during the day. Walleyes have slowed down quite a bit in the last week. There are few still being taken on night crawlers and crank baits. A good number of decent size white bass have been taken off the face of the dam with crank baits, shrimp and jigs. Quite a few catfish have been caught on typical baits. Division of Wildlife has approved the emergency fishing regulations. There is no daily bag, possession or size limits on any game fish. TIONS; The Visitor center is now summer to boating. Due to stafflaunched or operated at night on weekday nights (Sunday-Thursday). Current plan is to operate the park and the lake the same as last year with trailer launched boating available until Labor Day. After Labor Day, it is expected the lake will be lowered below the boat ramp to help come into Compact Compliance with Kansas.

> OHV AREA; OHV area has reopened. OHV's are not allowed to ride anywhere else other than the North Cove OHV area. Registrations available from the visitor center when open.

> FIRE RESTRICTIONS; Fires only allowed in Wagon Wheel and Foster Grove campgrounds inside designated fire rings. No fires anywhere else. Propane grills and stoves are O.K.

> CAMPING; Wagon Wheel campground is open and all sites have electric. The cost is \$20 per night. Wagon Wheel flush shower building and dump station open. Strongly recommend reservations for weekends with the easing of the fish regulations. Foster Grove campground is first come/first served with both electric(\$20) and non-electric (\$16) sites available and the shower building has opened.

**Road construction** to begin on I-70

I-70 from Caruso (Exit 12) and runs east to end at the east Goodland exit (Exit 19).

Workers will begin milling existing asphalt in the westbound driving lane as early as Thursday between Goodland I-70 Exits 17 and 19.

Construction began Thursday on contract – totaling \$1,132,733 – to driving lanes. The shoulders will Venture Corporation of Great Bend. The pavement repair project is funded by T-WORKS, the transportation program passed by the Kansas Legislature in May, 2010.
