# Ambulance agreement on table

nt.betz@nwkansas.com Sherman County commissioners and the Goodland Regional Medical Center administration talked Tuesday about looking for a middle ground way to handle the operation of the Sherman County ambulance service.

For more than a year the hospital has been telling the county they wanted to turn the ambulance service over to the county to reduce the cost the hospital is getting from Medicare.

Commissioner Larry Enfield said he met with Hospital Administrator Jay Jolly, Board Chairman Brenda McCants, Chief Financial Officer Jim Precht and Bruce Gleason, ambulance service director to talk about how the hospital was going to turn the ambulance service over to the county in September.

He said Jolly and McCants were talking about a middle ground option that could leave the ambulance service where it is, but turn it over to the county and have the hospital administer the service.

At the commission meeting Enfield told Commissioner Cynthia Strnad and Commission Max Linin about his meeting with the hospital board and administration.

He said he told the hospital people if the county were to take the ambulance service over the hospital ould lose the funding the county has been giving the hospital for operating the service. Strnad wondered if the county needs to be getting numbers, and called Jolly on the phone. Jolly said he was to have a phone conference with an attorney to see what might be done to draft an interlocal agreement that would put the ambulance service under the county, but the hospital would administer the service.

Weather causes wind damage

nt.betz@nwkansas.com Saturday evening about 7 p.m. Mother Nature put on a show with rain, lightning and high winds that caused some damage south of Goodland, and had sirens going off with reports of a possible tornado south of town. Meteorologist Dave Floyd, severe storm coordinator at the Goodland National Weather Service office, said he was out watching and taking photos of the storm clouds as they moved across the area, and said he had seen a cloud formation he lives about two miles southwest that at first appearance looked like a tornado. He said he had determined it was a scud cloud hanging down near the ground, but it was not a funnel cloud because he could not see any rotation. Jolly said the attorney might have some sample agreements, and this appears to be a middle ground approach for the service.

Strand asked Jolly if the county needed to be busting around getting numbers.

Jolly said Gleason was looking into that question. He said it might take some time if a Medicare number is needed, but said it is possible the hospital or county will have to get a new tax identification number for the ambulance service.

"Put it in the county's name and the hospital would operate it," Enfield said.

"Yes, it would be administered out of the hospital," Jolly said. "It would be through a separate set of books and take it out of the hospital cost report. We would have to deal with the square footage, but that would not be as much.

"I will know more after the phone discussion this afternoon."

Enfield asked if Jolly thought there would be a huge cost to the county

Jolly said he did not see it being a major change to the budget.

"It is the same service, and people to start with," he said. "As we go on we might have to modify the operation.'

Jolly said he should be able to get the county information in the next week.

## Courthouse improvement account created

nt.betz@nwkansas.com Sherman County commissioners agreed to use \$500 to open an account with the Sherman County Community Foundation to be able to accept donations to help with the courthouse improvements.

The commissioners met by phone with Jim Richmond of Energy Solutions Network of Nederland, Colo., who designed the heating, air conditioning and lighting upgrades for the courthouse.

On the phone was Elvira Stewart, a grant consultant the commissioners agreed to hire to help find possible foundation grants and donations for the improvement project.

The duct work for the heating and air conditioning part of the project is underway, and the lighting work will begin soon Richmond said.

Stewart said she has been looking for possible foundations, and felt having an account with the Sherman County Foundation a good first step. She said it fits well with the project.

She said she has found three foundations that appear to be possible places to apply for grant money. She said having the foundation account is good because it gives the foundations she is going to apply with a pass through and a way to get a tax deduction with the Sherman County Community Foundation.

She said the other option is the US Department of Agriculture development program, but this is fairly complicated.

She said the local banks are competitive, and the USDA can only be brought in on a financial need basis

She said the three she is looking at could be that size or larger. She said a problem is that some foundations do not like to get involved in a project that is ongoing.

Richmond said some parts of the project have not been started yet including the roof and lighting.

Commissioner Cynthia Strand said the county will have to do some refurbishing once the basic projects are done so there will be more work to do.

Stewart said that does help, and said it would be good to have other the Sherman County Community projects the county can develop.

county does not get any grants.

Stewart said having the account would allow the county to accept corporate donations.

Strnad said she felt the county commissioners would set up the foundation account.

Stewart said she would get started on the three foundations to see if the county can send in an application to get a pre-qualification.

She suggested the commissioners might want to look into some local business corporations in the community who might be willing and able to make a donation.

The commissioners unanimously approved setting up the Courthouse Improvement Fund through Foundation.
