Fire department consolidation on trial run

nt.betz@nwkansas.com A full room of people came to the city commission meeting on Monday to hear a discussion of possible consolidation of the Goodland Rural Fire department and the city fire department.

The city commissioners agreed to a temporary arrangement where City Fire Chief Brian James would serve as the Goodland Rural Department Chief in addition to his city duties while a proposed contract is developed to allow both departments to operate together.

City Manager Doug Gerber said he felt most of the people had come to talk about the fire department See FIRE, Page 5 cooperation issue.

He said the commissioners knew there was a vacancy for the Goodland rural fire chief, and the Rural Fire Board met last week and voted to offer the position to Brian

"We talked about this before and we felt we could proceed down this path because it was a personnel issue,"Gerber said."When it became reality we knew we needed to bring it to the commission for a policy decision.'

He said the big question is if the commission wants to move ahead with consolidation of these two departments. He said if the decision is to proceed it will take time to get the details worked out, but he said he felt the commissioners need to

KBI assists in downtown standoff, arrest

Traffic and business in the 1200 block of Main was disrupted late through a second story window and Tuesday afternoon and through the night as Goodland police with the assistance of the KBI handled a standoff situation with a man who had a gun in an upstairs apartment on the corner of 13th and Main Ave.

Approximately 4:00 p.m. on Tuesday, the KBI was contacted by the Goodland Police Department requesting assistance with a barricaded subject at 1220 Main Ave.

Goodland police officers had attempted to serve a court order on the subject, Ronald Calvin Kernal, 47, earlier in the afternoon at his upstairs apartment when the subject brandished a handgun resulting in the barricade situation.

Goodland Police Sergeant Greg Krosky and officer Cody Hanson had accompanied owner, Charlene Cole to the apartment to do a welfare check and attempt to serve a court order. When the apartment door was opened Kernal was holding a gun, and Krosky backed out and called for backup.

Sherman County Sheriff's deputies Asa Stiles and Jason Showalter responded along with Wildlife Conservation Officer Mike Hooper who took up stations in the hallway and across the street at 13th to watch the back door.

The KBI High Risk Warrant Team and a negotiator, Mark Kendrick of Colby, was called in by Krosky.

Once the area was secure Krosky had the area blocked off and set up a command post at Central Elementary to await the arrival of the KBI and the negotiator.

City employees set up barricades on Main and 14th to keep the onlookers back, and Krosky asked Sherman Theatre owner David Branda to cancel the show for the night to reduce the amount of people in the immediate area.

Kyle Smith, KBI deputy director said the organization tries to provide services the local law enforcement units may not have access to. He said the KBI brought a mobile unit from Great Bend to assist and provide a central command point.

The negotiator tried to talk Kernal nt.betz@nwkansas.com out, but before sunrise Wednesday morning the KBI team shot tear gas entered the apartment. Kernal was arrested after a minor struggle. No officers were injured.

Kernal was taken to Goodland Regional Medical Center to be checked out and then booked into the Sherman County Bastille with charges of aggravated assault and \$250,000 bond.

Smith said the local officers and KBI were to search the apartment on Wednesday to recover the gun or guns apparently kept by Kernal.

Acheck with the county attorney's office on Wednesday confirmed the search warrant had been issued and the officers had conducted a search of the apartment, but Assistant County Attorney Brock Abbey said he had not received any reports of what was


The Centers for Disease Con-
