# Republicans vote in new County Sheriff in Tuesday's primary

were scattered throughout the county, and were not enough to sway these races, however they could potentially affect the results of precinct committee races.

Despite dropping out of the race for District Court Judge several weeks ago, Colby lawyer Todd Stramel received 454 votes from Sherman County. His total, 1,532, was still dwarfed by incumbent Glenn Schiffner, who received 3,726 votes. The sole candidate for the other District Court Judge position, Scott Showalter received 1,180 votes in Sherman County.

Ron Schilling won the precinct committeeman seat for Llanos Township with 13 votes over Todd Quenzer, who had four votes. Joe Scheopner won Logan Township committeeman with 29 votes over John Topliff, 27, and Dennis Bentzinger, 15. Gary Winter won Stateline Township com-

committeeman with 194 votes over Kendall Gittinger, 90 votes. Jeffery Mason won Ward One committeeman with 168 votes over Michael Bretz, 116 votes.

Rumpel said she spoke to the Secretary of State's office, who told her that since Bergquist was running unopposed in Smoky Township, Rumpel can send a letter to the Sherman County Republican Committee, who can appoint Bergquist as precinct committeewoman.

In the Democratic Primary, Steve Evert received 29 votes for Commissioner District 3; Allen Schmidt received 88 votes for Kansas Senate.

Sherman County had 40 percent voter turnout, with 1,538 ballots cast out of 3,829 registered voters. Secretary of State Kris Kobach had predicted that, statewide, about 18 percent of those eligible would cast a ballot this election in Kansas.

There were 337 advance ballots.
