

## County working on 2015 budget

kbottrell@nwkansas.com Sherman County is in the process of determining its budget for 2015, and as part of that process, the commissioners met with County Attorney Charles Moser on Tuesday, who is proposing about \$5,000 more for his department's budget

Moser said the increases will mainly be in salaries and postage. The increase in labor is because his staff has been putting in overtime, mainly on drug cases. County Clerk Janet Rumpel said the department has taken in more than \$16,000 in attorney's fees.

The commissioners had a work session scheduled for Wednesday to continue discussing the budget.

The commissioners also discussed tax sales with Moser. The commissioners are attempting to go to a yearly tax sale.

Moser said he is not a fan of the letter the county sends to people who are on the delinquent tax list. This warning allows people to come in and pay just enough to get off the list, he said, rather than the full amount. Moser said once the petition is filed, anyone who comes in has to pay the full amount to get off the list.

Moser said he has asked the commissioners of other counties where he serves to not send the letter. Klemm agreed with Moser's assessment, and said had the commissioners thought of this before the previous sale they would have done it this way.

Moser also urged the commissioners to add a requirement to the abstracting bid that it be completed within 60 days.

#### State seeks Plot results commission

Grain growers in far western Kansas who plan to campaign for a seat on one of the state's five grain commodity commissions - corn, grain sorghum, soybeans, wheat or sunflowers – should be gathering petition signatures now to meet the Nov. 30 filing deadline.

candidates

The 2015 election will cover districts one, two and three; the western third of Kansas.

District one includes Cheyenne, Decatur, Graham, Norton, Rawlins, Sheridan, Sherman and Thomas counties.

To be eligible to run for any of the five commodity commissions the candidate must have been actively engaged in growing corn, grain sorghum, soybeans, wheat or sunflowers within the preceding three years.

Candidates must gather 20 signatures from eligible voters to be included on the 2015 ballot. No more than five signatures from any one county can be used to qualify a candidate.

Candidate registration packets are available from the Kansas Department of Agriculture or the grain commodity commissions.

## Rule would trace ground meat sources

U.S. Department of Agriculture's Food Safety and Inspection Service would require grocery stores and supermarkets to keep more documentation on ground beef sources, which could assist in more timely traceability of a particular beef source that may have caused a food borne illness.

The proposed rule would require retailers to keep records of all the sources of ground beef that they grindin-store, said Travis O'Quinn, assistant professor in the Department of Animal Sciences and Industry at Kansas State University.

Traditionally, he said, retailers combine beef purchased specifically for grinding with beef prod-

A recently proposed rule by the ucts that may have hit the end of rapidly and hopefully before the from the packers and producers to their shelf-life in a whole muscle cut form, such as roasts and steaks, to create the ground beef products consumers see on shelves. This limits traceability to a specific source of potentially contaminated meat if a foodborne illness outbreak were to occur.

'Currently, there aren't regulations that require those retailers to track what products, the amounts and the sources of those products that go into their store's ground product. The proposed rule would change that," O'Quinn said.

With the rule in place, consumers could potentially know about a ground beef product contaminated with E. coli, for example, more

product is consumed in the home,

For retailers, the rule would require extra record keeping on products all the way through the grinding process, but O'Quinn said this extra work could save the retailers time down the road if they needed to help public health officials trace down a contaminated product.

The rule does not affect the beef ground and packaged prior to the retail level, as these pre-packaged, case-ready products are already sourced, he said. It is intended specifically for meat ground in-store.

"Because of the added record keeping, we may see more caseready products coming directly

the retail store, already in a shelfready state as opposed to grinding

"This is just a proposal right now, so there is a 60-day time period where it will be open for comments, suggestions, thoughts and concerns," he added. "The USDA will review those comments before it goes into effect."



Kansas State University engineers have developed a lithiumbased neutron detector that is being recognized as one of the year's Top 100 newly developed technologies.

R&D Magazine is recognizing Douglas McGregor, professor of mechanical and nuclear engineering, and his research team with a 2014 R&D 100 Award. The award recognizes the year's 100 most significant high-technology new

The university-developed lithium-based neutron detector, called the Li-Foil Neutron Detector, can be used for medical imaging, national security, scientific research, oil well logging and the automotive

"We are honored to receive this international recognition for the collaborative efforts of students. faculty and researchers on our team," McGregor said. "All of the members of our team have worked very hard to advance this technology and take it to a whole new level. We continue to improve it and develop newer models.'

As a result, the lithium-based detector has several different applications, including stationary detectors that can be used at U.S. ports of entry, mobile backpack neutron detectors, and handheld devices.

"Our lithium-based technology seems to solve many of the problems in neutron detection," Nelson said. "Because lithium is less exmake some of the stationary detec-

can help the detectors be even more accurate."

Bellinger, who founded the Manhattan-based start-up company called Radiation Detection Technologies Inc., is helping with the commercialization of the neutron detector. Saint Gobain Corp. also is helping to commercialize the technology.

The engineers have one patent on the research, with another patent pending, and continue to improve the technology behind the neutron detectors. Their work has been supported by the Defense Threat Reduction Agency.

## RIP Tod Tiahrt

from our viewpoint...

Wichita-area voters apparently saw no appeal in a potential comeback for former Congressman Todd Tiahrt, consigning him to the political dustbin with a resounding 42,877-to-25,501 defeat by his successor, Rep. Mike Pompeo.

As he did against former Rep. Jerry Moran of Hays in 2010, Mr. Tiahrt ran a shrill, almost offensive campaign against the incumbent Republican who'd replaced him. Constant e-mails trumped every supposed slight or misstep by Rep. Pompeo.

The tone was reminiscent of the Senate race against Mr. Moran, which wound up with the western Kansas representative in Washington and the former union official looking for a job.

Apparently, it didn't set well with voters this time, either. Mr. Tiahrt apparently thought he had a chance this year to

unseat his successor. Why he waited four years to try to reclaim his old seat, no one could say.

Back in 2010, when he hoped to step up and replace Sam Brownback in the Senate seat, Mr. Tiahrt ran snarky ads claiming that he was the "real" conservative in the race and portraying Rep. Moran as some sort of mushy middle of the roader.

The facts showed that in Congress and in the Kansas Senate, Mr. Moran had a solidly conservative voting record, focused on spending and budget issues. He voted against many bills backed by the Republican leadership in those heady days, including President George W. Bush's landmark No Child Left Behind Act, a massive federal intrusion into local schools, and other budget-busting bills.

Of course, Sen. Moran won the Republican primary by a good margin. We thought, or maybe hoped, that we'd heard the last of ex-Rep. Tiahrt as Rep. Pompeo took office that year.

It was not to be, however. Mr. Tiahrt tried to come back. Though we didn't get much of the advertising out here, except on Wichita television, the 4th District race got downright mean. The Tiahrt campaign continually attacked the incumbent, creating no end of ill will within the party.

Voters apparently weren't impressed, handing the incumbent a 63 percent-to-37 percent victory. Maybe Mr. Tiahrt will get the message this time.

After the coming shakeup in the Republican party, the GOP will need to put a premium on unity, especially the conservatives. The time for the kind of destructive campaigning Mr. Tiahrt specialized in will be past.

The party will need candidates who focus on their own positives and don't try to destroy other Republicans.

Mr. Tiahrt's is a lesson the entire GOP needs to take to heart. -Steve Haynes

## Value of human life

During the Vietnam War, my mother, an otherwise sweet and compassionate person, said "they" (Vietnamese) don't value human life like we do, suggesting that I be more comfortable killing them. I never was comfortable with the idea of killing them, and so I didn't.

However, I still hear some people say that an "enemy" doesn't value human life like we do. Over the years, the enemy changes, but the refrain is the same: some people on "our" side believe that enemies think life is cheap and therefore expendable, to be easily sacrificed. These same people in our society believe that we, and probably our allies, think life is sacred, and only sacrificed in freely chosen heroic acts.

Whenever mass violence and war breaks out, the mainstream media decides (most often with the help of government spokespeople) who are the good guys and who are the bad guys, who is the enemy and who are the allies. Once this occurs, and media footage and commentary follow the script, it is surprising how many members of the public become comfortable with the killing of "enemy" people, especially when they are of another race, nationality, or

religion.

Suddenly the term "enemy" expands to the whole population of people (civilians, children, the elderly) and they collectively become evil, treacherous, and targetable. We can justify our hard-heartedness towards this enemy by saying they do not value human life like we do.

We look at what the enemy has done to us, or our allies, and ignore what we, or our allies, have done to them. Through the entire news cycle, the mainstream media, selected public officials, and commentators continually feed this mismatch of perceptions. The psychological term for perceiving the enemy to be inhuman is called "enmification." Perversely, then, life becomes cheap for us, as long as it's lives of the enemy. Falsely seeing the enemy as evil, and then doing evil to them, is deeply

ironic and doubly unethical.

What would the world look like if we took a compassionate view? It would look like the world that my international students in conflict resolution tell me about, a world where every culture has a spectrum of good people who just want to live their lives in peace, and extremes of people who have been driven to use violence out of fear or the evils of oppression.

Across the globe, we all similarly value life. but security fears, and campaigns for self-rule, often drive people to violence. They resort to violence because they have yet to learn the power and effectiveness of nonviolence, which has now been thoroughly studied to show how it has become much more effective than violence in creating security and democracy. Excusing violence against people by claiming that they don't value life is one of the greatest ethical oxymorons of our time. This practice should be abandoned forever.

## Unseen consequences

Some people routinely extoll the benefits of handing out taxpayer money to a few chosen businesses, and now the City of Wichita wants to create a sales tax that would generate \$90 million for business subsidies. Proponents say subsidies (cash payments, forgivable loans, earmarks, tax abatements, subsidized borrowing, etc.) are necessary for economic development; some even go so far as to call the practice 'essential' and 'critical.' Albert Einstein, on the other hand, might call it 'insanity,' as government has been giving away Other People's Money (OPM) for decades and still expect different results.

Subsidy proponents may have noble intentions but they don't consider the unseen consequences of their actions.

Dealing in OPM actually worsens economic conditions for those who don't receive subsidies. The lucky few recipients certainly benefit but their gains come at the expense of everyone else. Citizens pay higher taxes to generate the subsidies and shoulder the burden of tax abatements. Businesses not subsidized by taxpayers are also disadvantaged.

Washington University political science professor Nathan Jensen is co-author of a study that examined the use of subsidies in Kansas. A recent Wichita Eagle story about Jensen's research said "There is 'no evidence' that those oft-used tax incentive programs have

any positive effect on job creation. In fact, by cutting into public funds that could have been used for other programs that, say, spur private investment or fund research, and by making it harder for employers who do not receive tax breaks to compete in the market, the programs may actually have a detrimental effect."

Jensen found that in the six years after incentives were awarded, "the firms who received incentives actually generated slightly fewer jobs than those that didn't receive incentives." The Eagle went on to say "After the initial bump resulting from their relocation, Jensen found that transplanted companies were no more likely to generate jobs than similar companies that were already operating in their state."

Proponents of subsidies, earmarks, etc. talk about the jobs they believe were "created" but they don't provide the whole story. Jensen's research says subsidies having little positive effect on job creation and the Sedgwick County jobs data certainly bears that out. According to the Bureau of Labor Statistics, private sector

jobs grew just 1.1 percent between 2003 and 2013. Aerospace employment declined 8.8 percent even though the industry collected a lot of taxpayer money over that 10-year span.

It's fair to say that the aerospace decline is impacted by the global economy and should be discounted, but then economic development programs should not be credited for job growth in the education and health care sectors. The bureau counts many public school employees as private sector workers and Wichita's aging population is primarily responsible for the growth in health care.

Guess what? A grand total of 536 other private sector jobs were added in Sedgwick County, for a scant growth rate of 0.6 percent.

The growth in property tax collections, however, is considerable. According to the Kansas Department of Revenue, the City of Wichita increased taxes by 92 percent between 1997 and 2013; Sedgwick County taxes increased by 79 percent.

The best things government can do to promote job creation is to eliminate unnecessary regulation, operate more efficiently, stop dealing in OPM and use the savings to reduce

# Preservationist works to save old barns

Director Huck Boyd National Institute for Rural Development at Kansas State University Can a barn be reborn? Today we'll

meet a man who believes strongly that barns are a vital element of our history and that they should be utilized and preserved. His personal journey in barn preservation has led him to rural Kansas.

Roger Hubert is a barn preservationist. He grew up in Johnson County. His grandparents farmed near Topeka.

One of his uncles had a large limestone barn and house on a farm near Alma where Roger spent his summers. "I was mesmerized by it," Roger said. He was fascinated

the old stone barn which had been

Roger was especially interested in history. "My granddad would be diggin' post holes for fence when I was a kid," he said. "But I wasn't much help `cause I was looking for arrowheads in the dirt."

Roger attended the University of Kansas where he studied architecture, art history, and archaeology. He went on archaeological digs in Italy, Greece, Egypt and Central America. He always was interested in saving and restoring old buildings. While in New Mexico, he found he could make an income from saving and selling old, historic

by the shape, scale and history of Lincoln County, New Mexico, he saw a nice painting of a small farmconstructed by a Civil War veteran. stead silhouetted in a sunset. He bought the painting for five dollars, took it home, hung it up, and said, 'There's my dream house.'

> Meanwhile, a large, rundown ranch named Los Luceros was up for sale in New Mexico. Roger outbid a developer and found a way to buy the ranch and restore its historic buildings. That ranch is now part of the state's museum and park system.

> "I'm glad I was able to save Los Luceros," he said.

His ultimate goal was to find and restore a genuine stone farmstead in an undeveloped area of the Kansas prairie. He made lots of trips back to Kansas and eventually moved One day, in an antique store in back, but couldn't find just the right

place to restore. "I had lots of goose chases," he said. "There were stone houses without barns and barns without houses. Some were too far gone, and some were too close to a highway for me."

One day, Roger stopped in at an antique store in the rural community of Wilson, population 791 people. Now, that's rural. As he had done at countless locations before, Roger asked the store owner if he knew of any limestone farmsteads for sale in the area. Directions were given to one possible place so Roger drove out to see. Unfortunately, there had been a house fire and the barn had fallen down. It was yet another

Roger ventured on down the dirt road a ways and then something

caught his eye. It was a small stone they literally matched the scene house, barn, and pond with cattle grazing around it. No other development was in sight. To Roger, it looked just right. "The farm found me," he said.

But there were a couple of problems: First, the buildings were very run down, and second, the place was not for sale.

"There were six brothers and sisters who had inherited the place, plus their spouses, and they hadn't thought on selling anything," Roger

It was time consuming but Roger persisted. Eventually he bought the farmstead. One day he was taking pictures there as the sun was setting. When he saw the photos and shadowed house, he realized that

in the five dollar painting he had purchased years before which depicted his "dream home." Roger is restoring the home and barn while living there.

"That painting was my road map from Lincoln County, New Mexico to Lincoln County, Kansas," Roger mused, as it gave him his own stone

barn to rescue.

Can a barn be reborn? Yes, and saving the barn can save the homestead, Roger believes. We commend Roger Hubert for making a difference with his passion for preserving old barns.

And there's more. His heart for saving barns has extended into a statewide organization. We'll learn about that next week.
