Control city moves to subcommittee

The Goodland Star-News An application to designate Goodland as a "control city" for distance signs on I-70 has been approved by the state and moved up to the national level, Sherman County commissioners were told last Tuesday.

Carolyn Applegate, economic development director, said the application has been forwarded by the state to the American Association of State Highway and Transportation Officials subcommittee on traffic engineering.

A task force selected by the chairman of the subcommittee will review the information and make a recommendation to the subcommittee either by mail ballot or at the panel's annual meeting which has

Recommendations from the subcommittee will be presented to the association's standing committee on highways and board for ap-

Applegate said the fact the state has moved the application forward is a major step, but it could take a year or two for it to be approved at the national level.

In the meantime, she said, the state Department of Transportation is holding up some I-70 sign work to see if Goodland gets the control city designation.

Control cities on I-70 west of Thursday. Goodland are Denver, Limon and Hays, Salina, Topeka and Kansas

The control city designation would mean Goodland would be added to I-70 signs which now lists Salina heading eastbound and Limon heading westbound.

Applegate said a detailed presen- Kevin Rasure said.

tation was developed for the state explaining the reasons Goodland should be considered for the designation, and she was pleased the state has recommended the application to the national group.

"This is one of those projects that you hurry to get the presentation ready and then have to wait for the process," Applegate said. "We did not expect it to be a fast process, but having the state's approval and support is a big step.

Courthouse floor to undergo major cleaning

The terrazzo floor on the main level of the Sherman County courthouse is being readied for a major cleaning, commissioners were told at their meeting last Tuesday.

William McKnight, building maintenance supervisor, said he has been stripping the wax along the edges to get the main floor. That has left a narrow strip of clean floor which is much lighter and brighter than the main area, giving visitors an idea of how dingy the floor has

Man shoots himself A St. Francis man apparently ing himself.

killed himself Wednesday night with a .22 caliber rifle after an argument with his former girlfriend at her home about six miles southeast of Goodland.

Sherman County Sheriff Doug Whitson said Roger Curry, 42, shot himself in the head sometime around 8 p.m. at 2560 Road 62, where Curry and Tamara Espinoza, 45, lived together until they split up about two weeks ago.

Whitson said it appeared the two were arguing and Espinoza witnessed the shooting. The sheriff said the report from Undersheriff Kevin Butts, the first law enforcement officer on the scene, said that Espinoza told him Curry had pointed the gun at her before shoot-

Butts reported that he found the the head bleeding from the mouth, nose and ears, and had no pulse. Deputy Roger Studer arrived a short time later and the two conducted an initial investigation.

Sherman County emergency medical service was dispatched and emergency medical technicians started cardiopulmonary resuscita-

Curry was taken to the emergency room at Goodland Regional Medical Center, where he was pronounced dead by Deputy Coroner Travis Daise. Dr. Daise ruled the death a suicide.

Curry's body has been taken to St. Francis for funeral services.
