

Jennings Coyotes compete at Cheylin, Triplains Invite

The Jennings High School Track team competed in the Cheylin Track Meet on April 8 and the Triplains Invitational in Oakley on April 13.

Cheylin Track Meet
"Needless to say, I'm very proud of the way our kids are doing this early in the season," said Coach Russ Aumiller. "We were just a few points away from winning the Cheylin meet, coming in second behind Weskan."

"There are not many teams at this meet and no medal awarded, yet it's still a lot of fun for the athletes. It gives them a good idea of the work they are going to have to

put forth in order to reach their goals for the season."

"The 32nd annual Triplains Invitational at Oakley was our second meet for the year," said Coach Aumiller. "I can't praise our athletes enough. They had not practiced for four days because of the Easter break, yet they still competed extremely well."

"There were 16 other teams at this meet so we had plenty of competition. Our 51 points was good enough to place us fourth overall

in the boys division."
