

Public hearing will be held on the 20th day of May 2004, in the offices of Kansas Development Finance Authority, 555 S. Kansas Avenue, Suite 202, in Topeka, Kansas at 9:00 a.m., or soon thereafter, on the proposal for the Kansas Development Finance Authority to issue its Agricultural Development Revenue Bonds for the Projects numbered below, in the respective maximum principal amounts.
