

Racing fans treated to double features

Fans at Elmwood Park Speedway were treated to double features Saturday night. Features from the previous week were rained out and were ran first on the evening's card.

In the IMCA Modified make-up feature, Norton's Steve Reedy took the early lead with Darin Schartz and Jeff Walters in hot pursuit. Walters, of Commerce City, Colo., worked his way to second when Doug Shearer spun on lap 5 to bring out a caution. After the restart, Walters bided his time and passed Reedy for the lead on lap 8. A caution on lap 11 kept the field close as Tim Watts had worked his way to second, only to break and drop out on lap 14. The 'Rajin Cajin' was able to lead the break of the way to score the win, followed by Brian Calhoun, Rick Schwab, Marty Clark, and Shearer.

The IMCA Stock Car make-up feature had a rough time getting started. The caution flag flew twice without even getting a lap in, and in the process, 4 of the 16 starters were eliminated. Nathan Glendening led the opening lap, but gave way to Josh Hudson on the next lap. The final caution came on lap 13 when Glendening spun, bunching up the field with Hudson, Mark Zorn, Jason Schoenberger, Kelly Ford and Jason Rogers lined up in the top 5 spots. Zorn, of Russell, made the winning pass on lap 15 and was

able to hold off Hudson, Schoenberger, Rogers and Ford to the wire.

Kingsington's Cory Struckhoff took the lead from Dresden's Dave Meitl on lap 3 of the IMCA Hobby Stock make-up feature and led the remaining 9 laps for the victory. Wade Wagenblast finished a close second, trailed by Kelly Karnopp, Barry Schoen and Brady Schoen.

Norton drivers dominated the Cruiser make-up feature. Rhona Annon and Josh Wonderly took the lead at the drop of the green, but Wes and Chuck Eagleburger assumed command of the 10-lap race on lap 5. Kirk Persinger and Justin Graham made the winning pass in the final laps to score the win over the Eagleburgers and Annon and Wonderly.

The regular race program then got underway with heat races in all four divisions.

The Cruiser feature was the first to the track, and a second lap mishap eliminated four cars in the 10-car field. After the restart, the Eagleburger brothers, who had led from the drop of the green, were again chased down by Persinger and Graham, who made another late pass for their second win of the night. Jason Albrecht and Gary Rennebeck finished third. Heat race winners were Persinger and Graham and Annon and Wonderly.

Fifteen cars took the green in the IMCA Hobby Stock feature with Kale Shank of Smith Center jumping out front. But Norton's Kelly Karnopp took the lead on lap 2 and led the remaining distance of the caution free race to score the win. Wagenblast finished in the runner-up spot once again, followed by Brady Schoen, Garrett Brown and Shank. However, on the final lap, Schoen made contact with Tracy Holloway which dropped him from third to 12th, and track officials bumped Schoen one spot and awarded Holloway third place. Brady Schoen, Karnopp and Barry Schoen won the three heat races.

The IMCA Stock Car feature had fans on the edge of their seats as nine cars battled up front for most of the race, running side-by-side and nose-to-tail. Glendening led lap one, but Jay Hackmeister took the point on lap 2. That held up for 5 laps before Edmond's Randy Clydesdale took the helm. The battle was on until the lone caution flew on lap 17 for debris. Clydesdale was able to hold off a hard charging Hudson for the win. Ford was third, followed by Schoenberger and Rogers. Heat race winners included Hackmeister, J.R. McCreery, and Rogers.

Hoisington's Mike Petersilie led all 20-laps of the caution free IMCA Modified feature. The battle throughout the race was for second place, which Norton's Jim Arnold won over Darin Schartz. Tim Watts, who borrowed his



brother's car to run the feature after his car broke earlier in the night, finished fourth, with Clark rounding out the top five. Petersilie and Arnold won the two heat races.

Racing action returns to Elmwood Park Speedway on Saturday, June 5, at 7 p.m. with the regular four classes doing battle.
