BE IT ORDAINED by the Governing Body of the City of Norcatur, Kansas

**Section 1. WATER RATES.** Water consumers in the City of Norcatur shall pay for their use and consumption of water furnished or supplied by the city at the monthly rate of \$8.00 for the first 2000 gallons or any part thereof with

all water delivered above 2000 gallons to be charged at the rate of \$2.00 per thousand gallons or any part thereof.

**Section 2.** This ordinance shall take effect and be in full force from and after its publication in the official city newspaper.
