Rotary BB Gun team wins state

The Norton County Rotary BB Gun Team won Norton's 38th State BB Gun Championship in the last 45 years during competition in Alma on Saturday.

Not only did the young girl and boy marksmen from Norton County outshoot all the other teams, they also had the top score in the written test of hunter safety knowledge!

"We had done well in the two regional 4-H shoots and were shooting well in practice so I was pretty confident coming in," said Norton head BB gun coach Cameron Archer.

"I knew if we stayed focused we'd be okay.

"We were up and down a little but overall we shot exactly the score we needed to shoot. Our shooting score would normally rank in the top ten in the international shoot and we are looking forward to competing there.

"It was a great team victory. Every one of our Yellow Team shooters had good scores. No one let us down. It was great!"

"They exceeded my expectations on the written test," said Norton's classroom

instructor and former Norton shooter Chandra McKenna.

"I'm very proud of all of them."

Members of the state championship Norton Yellow Team were Lane Archer, 14; Gabriel Bird, 14; Zachary Bird, 14; Erin Archer, 12 and James Berry, 11.

They combined for a shooting total of 1845 and finished 20 points ahead of second place Wyandotte Gold. In the written test, Norton scored a 468 to finish six points ahead of runner-up Wyandotte Gold.

Alternate marksmen on the Yellow Team were: Miles Harrington, 9 and Lane Gruwell, 8.

Cameron Archer was the Yellow Team's coach.

The written test was taken first thing in the morning and prior to any of the four shooting positions but scores were not announced until after the shooting scores were posted.

Norton finished with a total shooting and test score of 2313 and Wyandotte Gold was second with a 2287, a total of 26 points behind.

Third place went to Derby with a 2215 total.

Legislative bill goes back to House

SB 463, the Senate bill that would have allowed Norton County to increase its debt limit, was removed from the governor's desk and will be read on the House floor early this week.

Norton City/County Economic Development Director Diane Stiles said the move was requested by a House member who was concerned that the bill would affect Wyandotte County. SB 463 referenced Wyandotte and Franklin Counties but does not affect them.

"Our consultants met with this legislator and it was simply a misunderstanding. No opposition to the bill is expected,"

she said.

Pinegar, Smith and Associates was the consulting firm hired for the Promoting Norton County Initiative. Stiles said they took SB 463 on pro bono.

Stiles said the bill is not in jeopardy, and final action should be taken next week.

Other bills that could have an effect on Norton County include:

HB 2496: Historic Tax Credits

Last year, the Legislature attempted to cut Historic Tax Credits 10 percent. Rather than cutting the total allocation 10 percent, they cut the rate 10 percent. Stiles said the tax credits were more difficult to sell and resulted in a 60-70 percent cut to

Busy year for local office

2009 was a busy year for the Norton City/County Economic Development Office with new projects starting and several projects being continued from past years.

At Tuesday's Norton City/County Economic Development meeting, Diane Stiles, director, gave the board a presentation of 2009 activities. She has been giving her semi-annual update to city councils as well.


She said economic development assisted over 40 businesses with projects,

offered a variety of courses, guided one business through the Norton County Revolving Loan Fund application, awarded two business education scholarships and expanded the resource library.

The Promoting Norton County Initiative began in 2009 with partnerships between local business owners, the Norton Community Foundation and economic development. Pinegar, Smith and Associates was hired as the consulting firm for the project, which has brought two legislative visits to Norton and the Norton Correctional Facility.

(Continued from Page 1) the program. This bill corrects the unintended consequences of last year's legislation.

"If we establish a historic district, these tax credits are essential to leveraging private investment in downtown Norton," Stiles said.

HB 2538: Promoting Employment Across Kansas

Stiles said the Promoting Employment Across Kansas (PEAK) legislation passed last year. It created an incentive program for competitive business projects by allowing qualifying employers to keep a portion of their employee withholding tax.

"This program modernized state incentive programs and also encourages development in rural

areas by requiring a minimum of five new jobs versus the 100 job minimum from the IMPACT program. HB 2538 makes technical clarifications that address unintended consequences of the program over the past year," she said.

SB 430: Rural Business Tax Credits

Legislators cut the value of the

Rural Business Tax Credits from 75 percent to 67 percent, and it translated into a 60 percent reduction in funds to the program.

The Rural Business Tax Credit Program funds the regional revolving loan fund under Northwest Kansas Planning and Development. The fund has awarded \$1.25 million in loans since its inception.

(Continued from Page 1) "I think this has been a very positive thing for the community," she said.

Stiles was also involved in wind energy, dairy, call center, motel and clothing store recruitment. She said economic development hosted community tours for some of the recruitment projects and met with developers. None decided to relocate to Norton County in 2009.

Business incentives included: the neighborhood revitalization plan, business education scholarship, enhanced enterprise zone, revolving loan fund, technical assistance, utilities to the meter (Norton) and \$5 building permits.

Individual assistance included awarding two business education scholarships, offered two business start-up classes, assisted over 25 entrepreneurs with business plans, financing, marketing or education, two entrepreneurs started businesses and one business owner received a loan from the revolving loan fund.

Another economic development project was the storefront renewal project which funded 17 applications. The total granted

was \$13,620.69 and the total investment was \$48,791.08. The program will continue in 2010. Applications are due March 31.

The Norton County Visitor Center, also known as the Moffet building, was another big project in 2009. The center received a grant from the Federal Home Loan Bank for interior renovations.

The project was delayed by an accident in June, but Stiles reported the damage repair is almost complete. She expects interior renovations will begin this spring.

The Dr. E.A. Lyons House was donated to the Norton County Community Foundation and recently received a \$90,000 grant from the Kansas State Historical Society Heritage Trust Fund.

The Heaton building was also donated to the Norton County Community Foundation. Work began on that building and included roof repair, exterior repair and paint and clean-up.

Stiles also worked on a historic district designation. She wrote a grant to hire a consultant to conduct a survey of downtown Norton and received funding from the Kansas State Historical Society Historical Preservation

Fund. The survey completion date and grant application deadline was yesterday.

Ten applications were approved for the Neighborhood Revitalization Plan in 2009 including: one Almena residential, one Densmore residential, four rural Norton residential, three Norton city residential and one Norton City commercial.

Stiles said there was not enough interest in the Housing Rehabilitation Grant program.

In other economic development business:

- The board discussed the contract with the Norton Area Chamber of Commerce for the Moffet building. Utilities were discussed with the board agreeing to a 70/30 split with economic development paying 70 percent of the utilities.
- A motion was made to approve the agreement. Vote taken, motion passed.
- Stiles said the copy machine needs repair. The 120K kit needs to be replaced, which will cost \$600 for the part plus labor and travel for a certified technician to repair the machine. The board debated buying a new machine or repairing the current one and decided to approve the purchase of a new copy machine. A motion was

made to approve the purchase, not to exceed \$2,999. Vote taken, motion passed.

- Stiles reported on the Leadership Kansas application. She received a \$600 scholarship to attend, and the remaining cost is \$900 plus hotel accommodations.

The course will take place from April-October with classes being held for three days in a different community each month. Stiles said it is a prestigious program and will benefit economic development.

A motion was made to approve Stiles' attendance in the leadership program. Vote taken, motion passed.

- The Storefront Renewal Project committee meeting date was set for 5:30 p.m. on April 8. Applications are due March 31.

- Stiles reported on the Vietnam Moving Wall, which will come to Norton in September. She asked the board to consider volunteering and said \$10,000 is needed to bring the wall to Norton.

The next Norton City/County economic Development board meeting will be held on April 13 at the economic development office, located at 133 N. Norton. All meetings are open to the public.
