

- 2) Locate the football games listed in each sponsor's ad. Decide the winner of each. Then write each winner on the official entry blank beside the name of the sponsor in whose ad the game appears. WINNERS MUST BE MATCHED WITH THE PROPER SPONSOR'S NAME IN ORDER TO COUNT. Don't pick ties because the contest is based on winning teams.
- 3) Write in the score of the tiebreaker game listed on the entry blank. It will be used to determine the winner only when several contestants pick the same number of wins.
- 4) Clip out the entry blank shown on this page or pick up identical ones in the stores of any of the sponsoring firms. NO ENTRIES WILL BE ACCEPTED UNLESS ON OFFICIAL ENTRY BLANKS.
