
Norton Cross Country headed for state

Until two years ago, the Norton girls and boys cross country teams had not qualified in the same year for the state meet but, in Cimarron in 2009, the

> Norton girls placed third in the regional and the boys finished runner-up. Last year, the girls won the championship and the boys were runner-up when the regional meet was held in Larned.

> The top three girls and boys teams qualified for the state meet along with the fastest 10 individual runners. Also qualifying for state are the top five individuals from nonqualifying teams if not in the top 10.

> The Norton girls won the championship with 43 points, followed by Thomas More Prep-Marian of Hays, 55; Lakin, 100; Minneapolis, 109; Cimarron, 113; Holcomb, 114; Scott City, 138.

> In the boys race, Holcomb was the champion with 59 points, followed by Norton, 83; Scott City, 91; Beloit, 119; Southwestern Heights, 123; Phillipsburg, 132; Minneapolis, 179.

"Our boys will tell you that they did not have their best day today," said coach Rossi. "Yet, they were able to out pace many Scott City runners in the last mile to overtake them and bring home the regional runner-up trophy.

The loss ended the season for Norton.

"Despite what the scores show, we really thought our girls played hard and did some good things," said coach Jilka. "Our serve receive was much better than it had been but we just didn't hit it like we usually do. We needed to be more aggressive at the net.

In the semi-finals, the Lady Panthers defeated Holcomb 25-7, 25-22 and in the finals they outscored Cimarron 25-12, 23-25, 25-23.

In the Class 2A Sub-State Tournament at Ellis, Smith Center won the championship to earn a State Tournament berth. They defeated Plainville 25-10, 25-11 in the first round, then outscored Oakley 25-12, 25-12 to reach the finals versus Hill City, who had defeated Trego 25-5, 25-13 and Ellis 25-12, 25-
