nortontelegram@nwkasnas.com When the Norton Community High School and Phillipsburg High School boys basketball teams play each other, extra bragging rights go to the winning coach and Friday night's game in Phillipsburg was no exception.

You see, Phillipsburg coach Keith Sides played for Norton coach Doug Reusink when they were both at Northern Valley.

Only a few points separated the two teams throughout the game until the Panthers finally pulled ahead to win 49-45.

Norton led 13-12 after one quarter and 26-25 at intermission. Phillipsburg moved in front 37-34 by the end of the third quarter, then outscored the visitors 12-11 in the fourth period to win by four points.

With just over four minutes left in the game, Blue Jays senior guard Dillon McConney stole the ball and drove for a layup and, on Norton's next possession, senior power forward Jordan Wahlmeier scored inside to tie the score at 41-all.

Phillipsburg hit two baskets in the next two minutes to take a 45-41 lead. Norton junior guard Jacob Brooks was fouled and swished two free throws with 1:25 remaining. The Panthers added two more baskets in the final minute, however, and Norton scored one more time on two free throws by Wahlmeier before time ran out.

Wahlmeier was leading scorer for Norton with 20 points on 9 of 17 two-point shots for 53 percent accuracy and 2 of 10 free throws for 20 percent. Brooks added 14 points on 1 of 6 from long range for 17 percent, 3 of 11 two-point tries for 27 percent and 4 of 17 overall for 24 percent and 5 of 8 free throws for 63 percent.

Derr had scoring honors for the Panthers with 14 points each.

As a team, Norton hit 2 of 18 from beyond the arc for 11 percent, 15 of 41 two-point tries for 37 percent and 17 of 59 overall for 29 percent.

Phillipsburg missed all 7 long range shots, hit 23 of 48 twopoint attempts for 48 percent and finished 23 of 55 overall for 42 percent.

From the free throw line, Norton swished 9 of 22 for 41 percent and Phillipsburg was accurate on 3 of 15 charities for 20 percent.

Norton pulled down 6 offensive and 23 defensive rebounds for 29 total and the Panthers grabbed 11 offensive and 24 defensive caroms.

Leading rebounder for Norton was Wahlmeier with 13, followed by McConney, 7; Tye Nickell, 4; Brooks, 3; Andrew Ellis, 2.

Wahlmeier blocked 2 shots and McConney rejected 1.

The Blue Jays had 13 turnovers but the Panthers lost the ball 18 times. Both teams had 14 offensive
