Mary Frances (Boyd) Logback

Jan. 19, 1940 - March 2, 2012

Mary Frances Boyd was born on Jan. 19, 1940 in Topeka, the daughter of F.W. "Bus" and Mary (Dexter) Boyd of Mankato. She passed away on Friday, March 2, 2012 at the Hays Medical Center in Hays, at the age of 72.

Fran attended schools in Mankato, graduating with the Mankato High School Class of 1958.

She entered Kansas State University seeking a degree in Clothing and Retailing from the School of Home Economics and was recognized by several Home Economics honoraries. She was a member of Pi Beta Phi social sorority and was active in the Student Government Association, serving that group for one year as its vice-president. She was also a member of Mortar Board at Kansas State.

She graduated from K-State in early June 1962 and, on June 15, 1962 married Jim Logback, Clay Center, also a 1962 K-State graduate. Later that month, she accompanied him to Newport, R.I., where he entered the U.S. Navy's Officer Candidate School.

They were later to live in Athens, Ga., where Jim was enrolled at the U.S. Navy's Supply Corps School, and then in San Diego, Calif., where he was stationed aboard the USS Jason (AR-8). It was there that their first son, Frank, was born.

Their daughter, Lydia, was born in Clay Center where Fran was visiting while Jim was overseas. The family moved to Hill City on Nov. 1, 1965 when Jim became associated with Fran's older brother, Bob Boyd, in the operation of the Hill City Times. Their second son, Steve, was born in Hill City.

Fran very much enjoyed working in several Hill City dress shops/clothing stores over the years. Most recently, she particularly enjoyed working with Kay Money in decorating the display windows of the UMC Second Chances thrift store in downtown Hill City.

She was a member of the United Methodist Church of Hill City and its Lydia Circle. She was also a member of the Helios Club of Hill City and had served as the Citizenship Chairman on Kansas' Sixth District of the General Federation of Women's Clubs. She served on the board of the Graham County Arts Council and was a member of Chapter CN of PEO.

Fran also enjoyed playing bridge and was a member of both ladies' and couple's bridge clubs.

Fran was always an ardent supporter of Kansas State University, particularly enjoying Wildcat football and basketball games, especially with her children and grandchildren. She took special pride that her oldest granddaughter is currently a sophomore at K-State and that her second granddaughter has enrolled there for fall classes, making the second member of the fifth generation of Fran's family to attend K-State. Her father was a captain of the 1934 basketball team and her grandmother is the namesake of Boyd Hall on the Manhattan campus.

Fran also very much enjoyed playing a very active role in the 50th Anniversary Reunion of her Mankato High School class in 2008.

Fran is survived by her husband, Jim, of the home in Hill City; and by their three

children, spouses and seven grandchildren: Frank, Zachary and Sierra Logback of Lenexa; Lydia (Bryan), Megan, Lyndsie and Denny Graham of Westborough, Mass.; and Steve (Donna), Elizabeth and Logan Logback of Manhattan; two brothers, Bob (Diane) Boyd of Hill City; and Dick (Mary Beth) Boyd of Norton; a sister, Elizabeth "Betty" (Wynne) James of Bethesda, Md.; a sister-in-law, Judy (John) Clift of Tulsa, Okla.; two nephews, six nieces and numerous cousins and friends.

She was preceded in death by her parents, Bus and Mary Boyd.

Funeral services will be held at 11 a.m. on Saturday, March 10 at the Hill City United Methodist Church with Rev. Mark Anderson officiating. Piano and organ music will be provided by Warren and Bev Stafford and the soloist will be Ron Radcliffe, who will be accompanied by Verna Jean Radcliffe.



Sign up program open

Enrollment for the 2012 Direct and Counter-cyclical Program will continue through June 1. The US Department of Agriculture computes payments using 85 percent of the base acres times the payment yield established for each farm. Eligible producers receive direct payments at rates established

by statute regardless of market prices. For 2012, advance payments are not authorized. Producers also have the option to enroll in the Average Crop Revenue Election Program. The optional program provides a safety net based on state revenue losses and acts in place of the price-based safety.

May 21, 1925 - March 3, 2012

Mrs. Florence Elizabeth Coe age 86, Hays (formerly of Norton) was called home suddenly early Saturday morning, March 3, 2012. Florence was born the first child of seven children to Clark Hodge and Inez Louise (Harris) Hodge on May 21, 1925 in Alma, Neb.

Florence attended rural school District 19 in Harlan County, Neb. and high school in Orleans, Neb. Following her formal education, Florence was employed as a housekeeper and also cared for her mother and baby brother.

On Nov. 17, 1942, Florence was united in marriage to Milo Burdette Coe at the Phelps County Courthouse in Holdrege, Neb. To this union, three daughters were born, Carol Marie, Janet Lue and Joan Sue. Florence resided with her husband, who was in the military at Camp Walters near Mineral Wells, Texas, for 14 months. She then

Noninsured crop disaster program application deadline is March 15

The deadline to purchase Non-insured Crop Disaster Assistance sorghum cane and sorghum dual purpose for forage and graze is March 15. Interested producers who may wish to participate in the program must visit their local Farm Services Agency office to complete an Application for Coverage (CCC-471) and pay the applicable service fee by the

applicable sales closing date for the specific crop. Administrative service fees are collected in order to help offset the cost of implementing the program and range from \$250 per crop per administrative county not to exceed \$750 per producer per administrative county with a \$1,875 maximum fee for multi-county producers.
