

Huskies just miss football win

In a hard fought game that was decided in the final minute, the Northern Valley Huskies lost a heart-breaker on homecoming to the Blue Jays of St. John's-Tipton Catholic High School, 32-28 on Friday, Sept. 28.

Junior running back Jordan Baird broke a scoreless tie with a 29 yard touchdown run midway through the first quarter. Sophomore running back Phillip Bryant rushed for the two point conversion, 8-0 Huskies.

Turnovers and special teams miscues plagued the Huskies throughout the game and led to several Trojan points.

Early in the second quarter, Blue Jays junior quarterback Connor Eilert navigated through the Huskies' defense on a 28 yard rushing touchdown and the conversion failed, 8-6 Huskies.

Less than three minutes later the Blue Jays struck again. Senior tailback Eriq Perez hauled in a 45 yard touchdown pass from sophomore quarterback Trey Dubbert, the conversion failed and the Blue Jays led 12-8.

Two minutes and 22 seconds later, the Huskies had a punt blocked by Blue Jays junior defensive end Luke Eilert, who returned it five yards for the score, giving the Trojans a 10 point lead over the Huskies going into halftime, 18-8.

"When you have two evenly matched teams, the team that makes the fewest mistakes usually wins," explained Huskies head coach Chuck Fessenden. "That was the case tonight."

St. John's-Tipton scored three

unanswered touchdowns in the second quarter but the Huskies came out of the break and dominated in the third quarter.

"Our kids played hard and made a good come back in the second half," said Fessenden.

Bryant's nine yard touchdown run brought the Huskies within four points, 18-14.

The Huskies regained the lead late in the third quarter on junior quarterback Hunter Chandler's 17 yard dash to the end zone, Bryant rushed for the 2-point conversion and the Huskies led 22-18.

"We were able to get the lead at the end of the third quarter. However, another mistake let them regain it in the fourth quarter," said Fessenden.

Eilert punched the Blue Jays into the end zone from one yard out and Dubbert completed a pass to junior tight end Caleb Brummer for the 2-point conversion and the Blue Jays were back on top 26-22.

But the Huskies continued to fight back. Late in the third quarter, Jordan Baird capped a Huskies drive with a seven yard touchdown run, the conversion failed, and Northern Valley was out front by two points.

"We were able to get the lead back with 3:58 to go in the game but we couldn't keep it," said Fessenden.

The Blue Jays went on a game winning drive that culminated with Perez scoring on a seven yard run and dashing the hopes of the Huskies and their faithful followers of a come from behind win. Northern Valley lost its homecoming in a thriller to St. John's-Tipton, 32-28 the fi-

nal.

The Huskies' ground attack compiled 252 yards on 60 carries. Chandler rushed 25 times for 99 yards and a touchdown, Baird rushed 15 times for 78 and two touchdowns and Bryant rushed 19 times for 74 yards and a touchdown.

The Huskies weren't as successful in the passing game. Chandler completed two passes on nine attempts for 19 yards and three interceptions. Senior end Tyson Callaway was on the receiving end of both Chandler

passes.

Junior Ian Vincent led the Huskies defensively with 10 tackles and nine assists, Chandler was in on 10 tackles and six assists, sophomore Ame Baird had six tackles and eight assists and Bryant had seven tackles and six assists.

"This loss really puts us in a tough position in district play," said Fessenden.

The Huskies will be back in action on Friday, Oct. 5 to take on the Natoma Tigers in Natoma at 7 p.m.

Tennis team places third in Trego tourney

Coach Jim Green's Norton Community High School varsity tennis team continued to play well on Saturday, Sept. 22 when they placed third in the tough Trego Invitational Tennis Tournament in WaKeeney.

It was Norton's highest finish in a number of years in this tournament.

Central Plains won the championship with 34 points, followed by Tribune, 32; Norton, 27; Phillipsburg, 20; Hoisington, 14; Trego, 10; Victoria, 9; Osborne, 8.

"We continue to be fortunate with the weather and had another great day for tennis," said coach Green.

"Our girls keep playing well week after week.

"This tournament is run differently than all the other regular season tournaments. It is run like the Regional Tennis Tournament. All the singles play together in one bracket and it is the same for the doubles. This is a disadvantage for the No.2 players because they are competing against the No.1 competitors. We did well in the seeding meeting, however."

No.1 singles

Norton senior Tawni Griffey, the No.1 singles player for the Lady Jays, continued her un-

beaten season by earning the gold medal. She outscored Jenna Dibble, Osborne, 8-1; shut-out Evin Smith, Tribune, 8-0; blanked Deiah Curtis, Hoisington, 8-0 and won the championship with an 8-0 victory over Breanna Schartz, Central Plains.

"Tawni continues to be extremely strong in her play and completed the day without a loss to claim first place," said coach Green.

No.1 doubles

Norton's No.1 doubles team of sophomore Brooke Sumner and junior Ashley Hildebrand was not seeded. They lost to Monica Valeta and Bailey Harris, Tribune, 8-2 and lost to Maegan Karlin and Brianna Leiker, Victoria, 8-1.

"Ashley and Brooke were not seeded and we did not get a good draw," said coach Green. "They drew in against the No.3 seed from Tribune."

No.2 singles

Norton's No.2 singles player senior Sierra Black defeated Brooke Schmidt, Victoria, 8-5 in the first round, then lost 8-1 to Breanna Schartz, Central Plains. She outscored Arika Aiken, Phillipsburg, 8-3 and lost the fifth place match to Taylor Noel, Osborne, 8-0, to finish sixth.

"Sierra was seeded seventh out of 16 entries and played well, advancing in the first round," said coach Green. "She

then played the No.2 seed from Central Plains. Sierra always gives her best effort but was unable to win. She won easily in the next round, advanced and finished in sixth place, one place higher than her seed."

No.2 doubles

Norton's No.2 doubles team of sophomore Molly Scott and junior Jessica White placed fifth.

They defeated Bailey Hobbs and Breanna Robben, Victoria, 8-1 but then faced No.1 seed Janae Hekele and Katie Hipp, Central Plains, in their next match and lost 8-0. In consolation play, they outscored Kimberly Day and Shaylee Flax, Trego, 8-4, then defeated Megan Robertson and Machaela Blakely, Tribune, 8-4 to finish fifth.

"Molly and Jessica were seeded eighth, which was good but we felt that they should have been the seventh seed. They won easily in the first round, then played the number one seeds Hekele and Hipp of Central Plains. They are an outstanding pair of players; too strong for us to defeat.

"The rest of the day went well for Molly and Jessica. Although their matches were close, they continued to win and finished fifth, three places above their eight seed."
