RESOLUTION NO. 2012-18 A RESOLUTION INITIATING THE PROCESS OF AMENDING THE NEIGHBORHOOD REVITALIZATION PLAN FOR NORTON COUNTY AND NOTICE OF HEARING THEREON

WHEREAS, pursuant to K.S.A. 12-17,114, et seq., the Board of County Commissioners of Norton County, Kansas, adopted a Neighborhood Revitalization Plan on November 13, 2007; and

WHEREAS, pursuant to K.S.A. 12-17,114, et seq., the Board of County Commissioners of Norton County, Kansas, adopted a Neighborhood Revitalization Plan on November 13, 2007; and

WHEREAS, it is necessary for Norton County to remain competitive and progressive in promoting potential business opportunities and residential housing development; and

WHEREAS, the Board proposes to amend the Plan in the following respects:

- **Remove the cap** for commercial improvements. Currently, the caps are set at \$50,000 for residential and \$250,000 for commercial.
- **Allow incentives to be transferred.** This would allow a bona fide developer who sells a property shortly after completion the ability to transfer the tax abatements to the purchaser.
- **Amend the Valuation and Application fee structure.** The chart below describes the proposed increases in application fees.

\$10,000 - \$25,000	\$100
\$25,001 - \$50,000	\$200
\$50,001 - \$150,000	\$500
\$150,001 - \$300,000	\$700
\$300,001 - \$500,000	\$1,250

AND WHEREAS, a public hearing should be held to receive comment and testimony from anyone regarding the determination to be made by the Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Norton County, Kansas, that a hearing before the Board shall be held on the 15th day of October, 2012, at ten o'clock (10:00) a.m. in the Commissioners' Chambers, second floor, Norton County Courthouse in Norton, Kansas, to determine whether the proposed amendments to the Neighborhood Revitalization Plan should be adopted.

BE IT FURTHER RESOLVED that this Resolution and Notice of Hearing shall be published once each week for two (2) consecutive weeks in the official County newspaper.
