cheaper in 2018, because the Holcomb plant will be paid off by then. The vote was taken and the motion carried.

Rob Lawson stated KMEA is doing away with its mutual aid program and so he talked to Prairie Land about them providing mutual aid instead. They will provide mutual aid for a fee. He also reported, the City tested the Load Tap Changer at Norton County Hospital and it was in good shape. One more substation will need to be tested at the swimming pool next spring. Lawson said the new Christmas decorations have been received and are being put up, and the materials are in to do the work on the storm sewer on Crane Street. Work is expected to begin after school is out. Lawson pointed out that the City has had a lot of water leaks lately.

The Council also carried a motion to have the Parks Department begin re-aligning the headstones in the cemetery and leveling the ground where the graves have settled.

Council member Roberta Ryan reported the Utility Committee met and discussed the water usage and sewer charge at the new ice plant.

Ryan also made a motion which was seconded by Ron Briery to adopt Resolution #13-2012, making a determination that there will be no automatic escalator for sewer service charges for the year beginning Jan. 1, 2013. The rates will not increase. A vote was taken and the motion carried.

The Council voted to adopt Resolution #14-2012, making a determination that there will be no automatic escalator for water

service charges for the year beginning Jan. 1, 2013 and Resolution #15-2012, making a determination that there will be no automatic escalator for refuse service charges for the year beginning Jan. 1, 2013. The rates will not increase.

The Council approved the Norton County Community Foundation's request to replace the sidewalk at 212 S. Kansas, with the City providing the labor and the property owner paying the cost of materials directly to the concrete provider.

Ron Briery said ideas for using the Hansen Foundation grant money will be discussed after the first of the year and stated, maybe some of it could be used to put something nice where the trees were removed in downtown.

wise, he said, the county will only have an easement and may not be able to do all it needs to do in the future.

"We don't know what's going to happen on that end of town," he said.

Engineer Kenzil Lynn said that a lot of county roads are put on easements, where the county doesn't own the land.

"And that's a problem some times," Mr. Miller replied.

Mr. Miller also noted that the county had some drainage problems in the area.

Mr. Porter asked if his firm could get some preliminary plans going so that they know

what will be needed for the right-of-way and construction schedule.

Mr. Lynn said that the overlay work will be pretty simple but the concrete will be a bigger deal.

Commissioner Miller said that both the county landfill and the sale barn must be considered when planning any reconstruction of the intersection because traffic will have to be rerouted during the construction and the county doesn't want either disturbed any more than necessary.

Mrs. Applegate asked how long the intersection might be

under construction and was told about three to four weeks. She said that the county needs to check the alternate routes and make sure all the bridges are strong enough for the expected traffic.

"We just need to go take a ride," Commissioner Miller agreed.

Commissioner-elect Charles Posson suggested that the county might look at a shoo-fly around the construction area, also.

Mr. Porter also suggested that the county could do a one-lane road through the construction but that he noted tends to raise the costs.
