

Logan athlete is best pole vaulter at Fort Hays State

Brady Tien of Prairie View, former outstanding all-around athlete for Logan High School, is continuing to have athletic success by specializing as a pole vaulter for Fort Hays State University in Hays.

As a sophomore this past season, Brady was the best pole vaulter on the Fort Hays State Track and Field Team. He had a very good season in spite of the cold and wet spring weather. Brady improved his vaulting so much that he just missed qualifying for the National Championships by three inches!

His best indoor vault was 15'3" when he placed second in the Charlie Foster Classic in Kearney, Neb. on February 1-2. That height tied him for 35th nationally at that time.

Brady's best outdoor vault came earlier this year when he cleared 15'11.75" to finish third in the MIAA Conference Championships, which were held at Fort Hays on May 3-5.

Realizing that scholarship is still the number one reason to attend college, Brady also keeps up on his studies. As evidence of this, he was one of only three members of the Tiger track team this past season to be chosen to receive the United States Track and Field Cross Country Association All Academic Honors. To earn this honor, a student-athlete must have compiled a cumulative GPA of 3.25 or bet-

ter and reached a provisional or automatic qualifying standard for the NCAA Championships in either the indoor or outdoor track and field seasons. Brady hit provisional marks in the pole vault for both the indoor and outdoor seasons.

He was also selected as an MIAA Scholar Athlete. You must maintain a grade point average of 3.5 or higher to be eligible for this award. Brady's major is criminal justice and he has a 3.66 GPA.

Brady also had an outstanding high school career, which included a gold medal in the pole vault his sophomore and senior seasons. He was third best state vaulter as a junior.

In his senior year at the State Track Meet, Brady easily cleared all heights until other competitors were eliminated and the bar was raised to 15'. He just missed that height in three tries so settled for tying his season's best at 14'6", which was a foot higher than the runner-up!

Brady hopes to improve his pole vault height enough this season to make it to the national championships. He is also looking forward to being able to practice in the new indoor training facility at Fort Hays.

Brady is the son of Patty and Scott Tien of Prairie View. His grandparents are Ann Tien and the late Henry Tien, Ron Shellito and the late Virginia Shellito and Connie and Doug Rice.

Caley Greving of Prairie View, a former multi-sport star for Logan High School, will be a sophomore basketball player this season for Kansas Wesleyan University in Salina.

The 6'1" center saw a lot of playing time last season as a freshman. She played in 26 games last season and played a total of 267 minutes. She hit 20 of 55 field goal attempts for 36 percent and 25 of 42 free throws for 60 percent and scored 66 points. She also grabbed 64 rebounds.

Her Kansas Wesleyan quintet finished with an 18-3 record and a runner-up placing in the KCAC conference tournament.

Caley received special recognition when she hit two key baskets to help her team defeat McPherson 54-48 after they had squandered a 17-point lead.

Caley is majoring in sports management.

She had a disappointment when she broke her hand in practice just prior to the post season conference tournament. She had to sit out the three tournament games which were the final games of the season.

Her hand is healed and she looks forward to starting a new season with the Lady Coyotes.

Caley competed in basketball, volleyball and track as well as being active in many organizations in high school. She competed at the state track meet all

four years in high school and was a member of the Logan High School volleyball team which placed fourth in the state in 2011. Her Logan Lady Trojan basketball team competed in the state tournament in 2011 and 2012. She was a member of the 4 x 100 meter relay team which medaled at the state track meet her junior year and she also medaled in the shot put at the state meet that year.

In high school basketball, Caley scored 1,270 points in her four year career and had a 40 percent field goal average. She also hit 60 percent of her free throws. She also pulled down 798 rebounds and blocked 103 shots.

Caley's parents are Cher and Colby Greving.

Her grandparents are Diana and Bill Greving of Prairie View, Don Grunert of Phillipsburg and Robin Norris of Manhattan. Her great-grandmothers are Mary Keith of Norton and Bonnie Rapp of Manhattan and formerly of Norton.

Grandfather Bill Greving played basketball for Prairie View High School, Dodge City Community High School and Fort Hays State University.

Bill will be inducted into the Fort Hays State University Athletic Hall of Fame this fall on November 2.
