In other business, the board:
• Decided to continue a contract with Phillips, Russell and Ellis counties to work with an on-line company, Nations Jobs, to promote job opportunities in the area. The one-year renewal

will cost Norton \$4,100.

• Agreed to help purchase a new Savin copier from Tri-Central Office Supply in Hays. The cost will be split four ways between the groups using the visitors' center including the economic development office, Norton Chamber, Norton Travel and Tourism and the Norton County Community Foundation. The economic development office will pay \$1,121.25 for its share of the machine.

• Learned that a meeting between Kansas Department of Commerce officials, architects and representatives of Northwest Kansas Planning and Development was scheduled for Dec. 19 to discuss outside structural rehabilitation for the Whitney Building, at the corner of Main and Kansas streets.

• The next meeting of the board will be at 5:45 p.m. Tuesday at the visitors' center at 205 S. State Street.

Kansas cattle reports vary

Kansas feedlots, with capacities of 1,000 or more head, contained 2.05 million cattle on feed on Dec. 1, according to the U.S.D.A.'s National Agricultural Statistics Service. This inventory was down six percent for last year. This is the lowest Dec. 1 inventory since 1994.

Placements during November totaled 370,000 head, down one

percent from 2012.

Fed cattle marketings for the month of November totaled 350,000 head, down 10 percent from last year.

Other disappearance during November totaled 20,000 head, up 5,000 head from last year.

Kansas milk production up 7.5 percent

The November 2013 milk

production in Kansas totaled 244 million pounds, up 7.5 percent from last year.

The production per cow averaged 1,810 pounds, up 40 pounds from 2012.

The number of cows was estimated at 135,000 head, up 7,000 from the previous year.


