closed," Thomson said. No local accidents occurred in the Norton County area due to the winds reported.

Traffic was backed up for several miles, and the Department of Transportation shut down U.S. 83 from the Nine Mile Junction to K-383 and K-23 just east of Selden at 2:50 p.m.. The closure was extended to Oberlin at 3:45 p.m.

The second accident happened when Gary Allen Godeill, 50, of New Haven, Conn., who was driving another semi-trailer rig toward Rexford, stopped almost a half a mile away from the pileup. The patrol reported that Wayne Haberstock, 69, of Alberta, Canada, hit his rig from behind. Godeill was OK, but Haberstock had to be taken to Hays Medical Center.

One fire official said the twisted pile of metal and plastic, with fire burning in the center, was the worst he'd seen in 30 years of rescue work.

County Attorney Steve Hirsch, training officer for the Sheridan County fire departments and the Thomas County department in Rexford, said it was frightening watching the fire rigs disappear into the wind-whipped dust clouds. Fire fighters had to get off the road and drive in the barrow ditch part of the way, he said, not knowing what might be coming at them.

"I couldn't have been prouder of my people," he said. "They went into it not knowing what to expect, and at some danger to themselves. They performed admirably."

Fire crews from Rexford, Selden and Menlo responded to the initial call, and were joined by a rescue crew from Colby. Ambulances came from Selden, Rexford and Colby.

Other accidents were reported across northwest Kansas as blowing dust reduced visibility.

By 5:15 p.m., all had reopened except U.S. 83 between U.S. 24 and Selden, which stayed closed as crews worked to untangle the mess and haul off the burned and battered vehicles. The road finally reopened about 10:45 p.m. By morning, several trailers remained, along with spoiled grain which was being salvaged for feed.

The first accident was reported on U.S. 36, shortly before that highway was shut down. An empty cattle truck rolled over about eight miles west of St. Francis. The Cheyenne County sheriff's office first reported the rollover at 1:31 p.m. The truck was partially blocking the road until it was removed by 3:51.

At 1:50 p.m., U.S. 36 was shut down from Atwood to the Colorado state line and K-27 from U.S. 36 to Goodland. The transportation department cited high winds and poor visibility as the reason.

Another truck blew over in the wind at mile marker 22 on I-70, just east of Goodland. A Sherman County sheriff's deputy pulled the truck driver, who was not hurt, out of the cab.

A UPS truck caught fire along the Sherman-Cheyenne County line after tumbleweeds got stuck underneath it. The fire spread to both sides of County Road 80,

burning the truck to the ground and scorching 200 to 300 acres of pasture.

I-70 from Colby to Burlington was closed at 2:50 p.m. One motorist ran around the barricades closing off the freeway about 4:40 p.m. He got a ticket and an escort back to Goodland. Officers reported trucks were still coming south from Nebraska shortly after 3 p.m., and the K-27 closure was extended from St. Francis to the state line at 3:30. These roads were among those opened at 5:15.

Brian James, Sherman County fire chief, said fire fighters slowed down to 10 or 15 mph as they looked for one wreck, because the dust cut visibility down to the point that they couldn't see the front of their vehicle.

Shortly before the wrecks began, Thomas County road and bridge Supervisor Clair Schrock called his crews in from the county because of the wind. Many went back out to man barricades.

Ambulances, fire rigs and patrol cars had to be cleaned as heaps of dust sifted inside the vehicles. Fire fighters hosing down the blaze were caked with mud as mist and dust mixed and settled on their bunker gear and faces.

Dave Floyd, warning coordination meteorologist with the National Weather Service, said strong winds 5,000 to 10,000 feet above ground mixed down toward the ground when temperatures climbed into the 40s around noon. The winds subsided around 4 p.m. when the temperature got cooler and cloud

The request was denied because it did not meet the specific requirements of the code. DSNWK was told they can build a porch but they can't put a cover over it. They Wyatt Family Trust requested a waiver at 807 Middle Street for a small porch on the front of their house. Because of the size of the lot, the
