

# Eleven measles cases reported

The Kansas Department of Health and Environment and the Sedgwick County Health Department have reported two additional cases of measles in Sedgwick County, Kan. One case was in an infant too young to be vaccinated and one case was in an adult. Both cases are epidemiologically linked to other known, recently reported cases of measles in Sedgwick County. In total, there have now been eight cases reported in Sedgwick County and three cases reported in Johnson County to date in 2014.

Measles is a respiratory disease caused by a virus. With the creation of the measles, mumps, rubella vaccine, measles cases have generally been rare in the United States; however, it still sickens approximately 20 million and kills 164,000 people worldwide each year. There has been a resurgence of measles cases in the United States in 2014. From January 1 through July 11, 566 confirmed measles cases have been reported in 20 states. This is the highest number of cases since indigenous measles elimination was documented in the U.S. in 2000.

Most measles cases in the United States have occurred among persons who are not im-

munized. "The best way to keep from getting the disease is by being vaccinated. Protect children by making sure they have the measles, mumps, rubella vaccine when they are 12 to 15 months old, and again before they enter kindergarten," said Robert Moser, Medical Doctor, The Kansas Department of Health and Environment Secretary and State Health Officer.

Measles is highly contagious and is spread through the air by breathing, coughing, or sneezing. The signs and symptoms of measles typically begin one to two weeks after someone is exposed to an infected person. According to the Centers for Disease Control and Prevention, measles is so contagious that if one person has it, 90 percent of the people close to that person who are not immune will also become infected with the measles virus. Symptoms include:

- Fever
- Blotchy rash on the skin, which spreads from the head to the trunk then to the lower extremities (Measles can be spread to others from four days before to four days after the rash appears.)
- Cough
- Runny nose
- Red, watery eyes (conjunc-

titivitis)

- Feeling run down, achy
- Tiny white spots with bluish-white centers found inside the mouth (Koplik spots)

Nearly one in three persons who get measles will develop one or more complications, some of which may be serious. These include pneumonia, ear infections, or diarrhea. Encephalitis, which is a severe inflammation of the brain, may also occur in some cases.

"If you have a fever, stay home except to see a healthcare provider. If you need to visit your healthcare provider, call ahead so appropriate measures can be taken to protect other patients and staff," said Adrienne Byrne-Lutz, Sedgwick County Health Department Interim Director.

People at high risk for severe illness and complications from measles include infants and children aged over 5 years, adults aged under 20 years, pregnant women, and people with compromised immune systems.

sidewalk replacement. The Council agreed to replace the sidewalks for Jason Jones at 514 N. State St., and for Patricia Brooks at 401 E. Lincoln St. The city will provide the labor and the homeowners will pay for the materials.

The council approved the hiring of an engineering firm, ElectricComm, to review the City's electrical systems and to conduct a study of the City's electrical needs at a cost not to exceed \$28,000. The study will tell the City what the electrical needs are, and capacity loads for now and in the future. ElectricComm was chosen from three proposals submitted.

The council also approved the first reading of Ordinance #1660, amending the city code

as to the appointment of the city administrator, requiring residency within 60 days of accepting the position.

The council accepted the resignation of Pat Morel as interim co-city administrator, but will continue his duties as Chief of Police.

Council member Roberta Ryan reported that the Chamber of Commerce's Winner's Circle will be held Sept. 13. Tickets will cost \$50 and five large prizes will be given out. There will be a casino open from 6-8 p.m., followed by a comedian at 8 p.m.

Karen Griffiths informed the council that she sent Prosser Wilbert Construction a letter of non-compliance for liquidated damages in the amount of \$3,500 for not meeting the deadline for the new swimming pool project.

Griffiths also said the City will not accept the curb and gutter work in the parking lot area and will charge Prosser Wilbert the costs of the City to hire a contractor to re-do the curb and gutter.
