ORDINANCE NO. 802

AN ORDINANCE AUTHORIZING SUNDAY SALES OF CEREAL MALT BEVERAGE IN THE ORIGINAL PACKAGE WITHIN THE CITY OF DRESDEN

BE IT ORDAINED BY the Governing Body of the City of Dresden, Kansas,

Section 1. Pursuant to KSA 41-2911, the sale at retail of cereal malt beverage in the original package is allowed within the city on any Sunday, except Easter, between the hours of 12:00 noon and 8:00 p.m.

Section 2. This ordinance shall be published once each week for two consecutive weeks in the official city newspaper.

Section 3. This ordinance shall take effect 61 days after final publication, unless a sufficient petition for a referendum is filed, requiring a referendum to be held on the ordinance as provided in KSA 41-2911, in which case this ordinance shall become effective upon approval by a majority of the electors voting thereon.
